## ***Summary of Accomplishments & Program Highlights***

---

- In October 2005, the Philadelphia Domestic Violence Hotline (PDVH) was launched. PDVH is a toll-free, bilingual phone line for victims of domestic violence. Funded by the City of Philadelphia, PDVH is a project in collaboration with Women Against Abuse, Lutheran Settlement House's Bilingual Domestic Violence Program, and Congreso's Latina Domestic Violence Program. PDVH was created to provide crisis intervention, danger assessment, emergency advocacy, and safety planning, as well as information and referral services.
- WIT volunteers and staff answered 3,769 calls to the Hotline and Lifeline- 47% for domestic violence, 22% for substance abuse, and 32% other.
- WIT's telephone counselor provided 1,237 hours of telephone counseling to 2,105 callers.
- WIT provided 2,995 unduplicated clients with 4,130 hours of direct service, including 8,128 client contacts.
- A total of 150 women received in-person intake assessments - 76% for domestic violence and 24% for substance abuse.
- WIT held 6 group cycles and provided 75 women with 1,016 hours of service through WIT's Lifeline Peer Support Groups.
- WIT Counselors provided 181 women with 871 hours of in-person counseling services.
- WIT staff and volunteers provided 56 children with 182 hours of Playcare activities and supervision.
- WIT staff conducted 22 training sessions for 399 individuals and 69 Community Education and Prevention Programs which reached 3,936 individuals.
- WIT's Annual Adopt-a-Family program connected 36 sponsors with 33 families, including 94 children who received holiday gifts and assistance.
- 18 Women graduated from WIT's Lifeline Peer Support Groups.
- WIT staff made 120 advocacy contacts, advocating for women through task groups, coalitions and community meetings.
- WIT staff conducted two 45-hour Domestic Violence/Advocate Training Programs with a total of 16 graduates.
- WIT distributed 1,360 SEPTA tokens to clients to assist with transportation to and from appointments at WIT.
- WIT distributed 20,000 Courage Cards throughout the community.



# Summary of Accomplishments & Program Highlights

- WIT’s Board of Directors held a retreat to initiate a strategic planning process, including a Board mission statement. Leadership for the retreat was provided by Patrice Morris, a member of the WIT Advisory Board, and through WIT’s membership in the Nonprofit Center, Pam Leland, PhD, a Nonprofit Center Board Corps Instructor.
- WIT’s Survivor’s Network, in its 5th year of operation had a busy year!
  - ◆ Collected “care packs” for military in Iraq
  - ◆ Collected/packed “cozy packs for kids” for the United Way Day of Caring
  - ◆ Participated in WIT’s annual adopt-a-family
  - ◆ Assisted the PDVH in the design and implementation of an evaluation tool
  - ◆ Participated in a documentary on women’s successes by a student from Temple University
  - ◆ Participated in a pilot study “Women’s Personal Needs” being conducted by a University of Pennsylvania Doctoral Student
  - ◆ Held a recruiting “fiesta” event to introduce the Survivors Network to recent WIT program graduates
  - ◆ Conducted two fundraising events to benefit
- 55 Volunteers provided 3,214 Hours of Volunteer Service including 1,898 On Call or On Line for the Lifeline

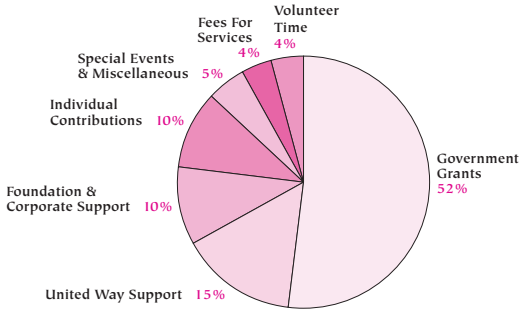
