

# Annual Report

*Fiscal Year 2011*

WIT's mission is to empower women to build lives for themselves and their children that are free from domestic violence, substance abuse and poverty; and to empower the community to undertake initiatives to end substance abuse and violence against women and children.

During fiscal year 2011, WIT helped 3,807 individuals via:

- Supportive telephone counseling through our LifeLine at 215-751-1111 and crisis counseling through the toll-free, bilingual Philadelphia Domestic Violence Hotline at 1-866-723-3014. WIT Counselors and trained volunteers provide supportive counseling, needs assessments, and information and referrals.
- Intake Assessments and Referrals
- LifeLine Peer Support Groups including our weekly "walk-in" group, Sister Circle; the Parenting After Violence group; and our Safe & Sober Group held at women's substance abuse treatment programs including Interim House East and My Sister's Place.
- Individual counseling and advocacy services
- Substance Abuse counseling services for women in recovery. WIT is unique in that it is the only agency in Philadelphia which provides services addressing both domestic violence and substance abuse.
- A comprehensive Community Education, Advocacy and Training program, including: Philadelphia's WAVE – a safety, self-defense and assertiveness program. Some of the businesses and organizations WIT reached this year include:

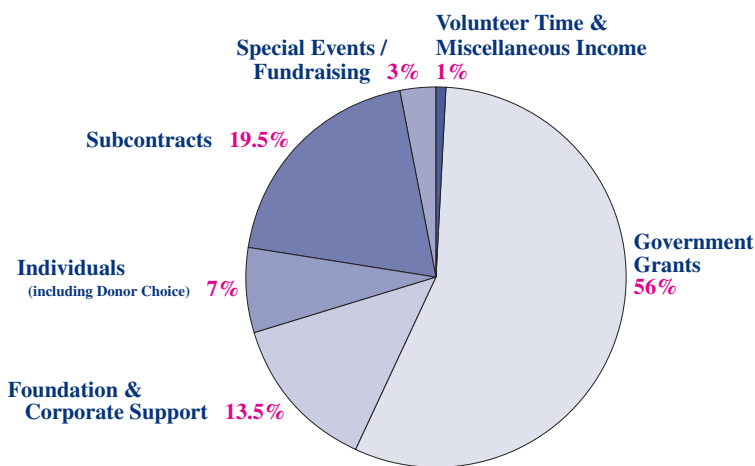

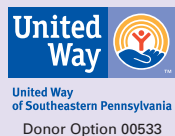
